What policy makers say about researchers?

- Lack of timeliness
- Politically irrelevant research
- Research for the sake of research
- Too much focus on the describing and managing the problem
- Lack of applicability to "real-life" solutions

What researchers say about policy makers?

- Decisions based on political preferences and money
- Lack of scientific evidence
- Too much partisanship
- Use of sta-twistics
- Lack of political will or action

What communities say about researchers and policy makers?

- Lack of personal contact between researchers, policy-makers and those most impacted by the "problem"
- Not enough action
- Lack of community voice & "real civic engagement in research & policy making
